(Non-Refundable, Non-Transferable Fee)

Re-enrollment registration for the 2012-2013 school year opens to current ECS students and their siblings on February 1, 2012. If you plan to have your child(ren) attend ECS next fall, the completed re-enrollment form and one-half of the registration fee for each child MUST be received in the ECS office NO LATER than February 29, 2012, with the balance of the registration fee due and payable NO LATER than June 4, 2012. Places for returning students can only be held until March 1.

Total Registration Fee for K-8 of \$285.00 per child must either be paid in full by February 29, 2012, **OR** \$142.50 by February 29, 2012, and balance of \$142.50 paid by June 4, 2012.
Total Registration Fee for Preschool of \$125.00 per child must either be paid in full by February 29, 2012, **OR** \$75.00 paid by February 29, 2012 and balance of \$75.00 paid by June 4, 2012.
